Safety Rep Information (Association and Team)

All minor hockey associations, leagues, programs and teams must assign one person who will be the Safety Rep responsible for ensuring that all updated and relevant information is passed onto everyone. The primary roles of the **Safety Rep** are to ensure the <u>Hockey Nova Scotia Dressing Room Supervision Policy</u> (Sometimes referred to as the Two-Deep Rule) is implemented, and to be available and ready should we have any COVID-19 protocols requiring implementation this season.

Team Safety Reps and the 'Two-Deep' Rule

Hockey Nova Scotia (HNS) requires all Coaches/Bench staff and member Minor Hockey Associations to provide supervision for all Minor Hockey dressing rooms before, during and after all games and practices. HNS requires that Minor players should be supervised at all times, HNS requires MHAs/ Coaches to follow the "Two-Deep Rule" of supervision recommended by Hockey Cana

da. A lone personnel member should never be in the dressing room with players at any time, especially when players are showering or changing: two adults must be present together, this is called the "Two-Deep Rule" of supervision.

Supervising personnel must be members of the team staff or adults who have completed either "Speak Out" or the "Respect in Sport" for volunteers and have submitted their record checks [VSC & CRC] to their MHA. All certification information for this required position can be found below:
